Back in the twenties, Fred L. Black, while on the Dearborn Independent, did a lot of research for the late Henry Ford in connection with the alleged escape of J. Wilkes Booth, the assassin of Abraham Lincoln.

Mr. Black's assignment took him to many places in search of truth and sworn affidavits, in an effort to expose for once and all-time the Booth escape myth, in which Mr. Ford was vitally interested at that time.

Findings of Mr. Black's investigation were published serially in seven issues of the Independent. I am interested to know if the original manuscript with the documentary affidavits are in the Archives, or elsewhere.

The articles were not copyrighted, nor was the Dearborn Independent, and I was informed that since the sale of the Independent, the rights of all articles reverted to original contributors.

When Mr. Ford disposed of his Independent, the transaction, I am told, included only the masthead, but not any other assets due to absence of copyrights.

If you can find anything in the Archives in connection with this matter, let me have a detailed report at your earliest convenience.
