

My patient - Mr. Thompson - told me, no coast-way shipping or trans-gulfian shipping was permitted by the

Remembering the Minneapolis Star's interview with Blanche de Bar and her statement of the incident in London when Wilfred was a boy, I tried to secure an interview with Mr. Clark but he would not grant it. What do you make out of her anyway? Her affidavit - a copy of which Wilson sent me - states she saw the corpse of St. Helen at Memphis and identified it as her uncle, yet in her interview she states she wished she might go to Memphis and see the body.

Wilson said Francis Wilson the actor told him he (i.e. Francis) was going to issue the memoirs of Edwin Booth in four volumes and he had found in looking over the diaries ~~found~~ under that date an account of a meeting in Paris of the assassin and the dramatist.
